

**13. ELO Resolution Awarding Contract for Downtown Infrastructure Project to Lowest Responsible Bidder**

Deputy Supervisor Brodsky moved, seconded by Council Member Katz, to adopt the following Resolution:

**WHEREAS**, pursuant to the provisions of the N.Y. General Municipal Law, the Town duly solicited bids for the provision of labor and materials for a public works project in the Chappaqua business hamlet known as the Downtown Infrastructure Project and which included the following construction activities:

- i. removal and replacement of 1,875± linear feet of 12" cement lined ductile iron pipe;
- ii. removal and replacement of 940± linear feet of varying diameter service and connection pipes;
- iii. installation of new valves, hydrants and fittings, temporary water service provisions;
- iv. removal and replacement of 1,800± linear feet of 8" to 15" ceramic epoxy lined ductile iron pipe, 600± feet of 4" sewer laterals, new sewer manholes, castings and covers, temporary sanitary sewer service provisions;
- v. replacement of existing 18" drainage trunk line with 785± feet of new 29" x 45" horizontal elliptical reinforced concrete pipe;
- vi. replacement and/or repair of existing catch basins, frames and grates;
- vii. milling and resurfacing of existing asphalt overlay, with areas of full depth asphalt pavement replacement;
- viii. installation of a traffic signal at the King Street and North/South Greeley Avenue intersection;
- ix. reconfiguration of the Quaker Road and South Greeley Avenue intersection;
- x. replacement of and/or upgrades to streetscape amenities, such as new granite curbing, concrete patterned and tinted sidewalks with brick paver trim, decorative brick crosswalks, ADA compliant warning surfaces, areas of decorative bluestone, ornamental LED lighting, new/refinished benches, trash receptacles, fluted bollards, bicycle racks, seat walls, ornamental fencing, an informational kiosk, planter boxes, new trees with identification plaques, tree grates and up-lighting and a decorative clock; and

**WHEREAS**, the Town received five (5) responses to its bid solicitation for the Downtown Infrastructure Project; and

**WHEREAS**, on April 21, 2017, the aforementioned bids were unsealed and ELQ Industries, Inc., located in New Rochelle, New York ("ELQ"), was determined to be the lowest responsible bidder at \$13,970,462.75; and

**WHEREAS**, after the bid opening, the Town Board directed its construction manager, Boswell Engineering, to negotiate with ELQ as to certain bid reductions; and

**WHEREAS**, ELQ has agreed to reduce the amount of its bid to \$11,600,000 by reducing the scope of work and certain unit pricing in its bid, as summarized in the annexed schedule and annotated site plans; and

**WHEREAS**, the Town Board is fully familiar with the Downtown Infrastructure Project and the aforementioned reductions in scope and pricing that ELQ has agreed to implement.

**NOW, THEREFORE, BE IT RESOLVED**, that the Town Board hereby awards the contract for the Downtown Infrastructure Project to ELQ, subject to the reductions in scope and pricing set forth in the annexed schedule and annotated site plans.

**BE IT FURTHER RESOLVED**, that the Town Administrator is authorized and directed to execute any documents required and to take all actions necessary to implement this resolution, subject to review and approval of Town Counsel.
